Subject: Regarding Creation of APAAR ID on UDISE+ portal of all the students for the academic year 2025-26.

Sir/Madam,

This is in continuation of this office letters and directions received from state Project Director on the subject cited above. In this regard, it is submitted that the State has achieved 62% creation of APAAR ID of students in the academic year 2024-25 as per the guidelines received from GOI vide their D.O. No. 1-27/2023-DIGED-Part(1) dated 2nd September, 2024.

As you are aware, this academic year the State has done progression of the student and also updated the General Profile (GP) and Education Profile (EP) of all students till date. Only after updation of GP and EP, we may start the creation of APAAR of students. In order to start the process for the creation of APAAR again, following guidelines is submitted:

- 1. All Blocks are requested to conduct orientation and review workshop with the Heads of All Schools related to APAAR implementation and meet out the expenditure from the grant of meeting TA at CRCC level for the year 2025-26 under the intimation to this office.
- 2. Detail guidelines may be issued to schools to conduct Mega PTM/SMC meeting and school may select any suitable date to conduct this meeting and expenditure may be booked from the SMC grant for the year 2025-26.
- 3. All blocks are requested to appoint Block Nodal Officer for this purpose.
- 4. Schools have to follow the guidelines as already circulated by this office in earlier correspondence
- 5. Concerned school will have to keep/maintain all the mandatory consent form received from the parents for the creation of APAAR ID & will keep them safe.

6. Students of classes 5th, 8th and 9 to 12th are to be covered on priority then it can be scaled to other classes.

You are requested to give your personal attention as you are the Nodal Officer at Block level in order to achieve the 100% saturation in APAAR. MIS staff of Block level dealing with UDISE may be directed to provide necessary technical support and correction in the profile of students if required in UDISE data.
